As per reference 1<sup>st</sup> cited above Administrative Sanction was accorded for the scheme “Agro Service Centres and Service Delivery 2017-18”. The services of Data Entry Operators engaged as per reference 1<sup>st</sup> were terminated as on 31/03/2018. Continuous sanction for the scheme for the year 2018-19 was accorded as per reference 2<sup>nd</sup> cited above and funds are earmarked for payment of Honorarium of Data Entry Operators engaged under NeGP-A up to 31st March 2019 in the revised rate of Rs.19,950/- per month and Rs. 407 Lakhs is set apart for the payment of honorarium to the Data Entry Operators up to 31/03/2019.

As per reference 3<sup>rd</sup> cited KAT Thiruvananthapuram have directed to formulate guidelines/parameters for assessment of the performance of the employees and to enter in to an independent decision as regards to their continuance based on the assessment of their performance.

As per reference 4<sup>th</sup> cited above it was directed to furnish the District level consolidated report of Data Entry Operators who have successfully completed the performance evaluation criteria.

As per reference 5<sup>th</sup> to 18<sup>th</sup> cited above Principal Agricultural Officers of all Districts have submitted the Performance Score Card of Data Entry Operators whose performance is satisfactory and their score is above 60% and there is no punishment/Disciplinary action pending against them. Principal Agricultural Officers have recommended to re-engage the Data Entry Operators as listed below:
